OPEN COMMENT –

Jonathan Lilja (Cahoy Pump Service) addressed the board regarding the recent service rendered at well house #2 (603 Main Street). Mr. Lilja demonstrated the reasons for the pump pull expense. The line shaft turbine that was installed in 2003/2004 was sized incorrectly and no scheduled maintenance was performed. Mr. Lilja explained the Village could install a submersible tank to replace the existing line shaft turbine. The future overhaul of well #3. Mr. Lilja explained measures to keep the tank in good working order. Mr. Lilja answered questions regarding fire suppression with the installation of the new tank. Mr. Lilja assured the board that the new tank would be refilled fast enough to manage the in-town fires. A proposal for the extensive work or "Phase Two" was given to the board in the amount of \$36,811.00. The board discussed and gave approval for President Morris to sign the contract.

NEW BUSINESS:

Trustee Plock motioned to pay Cahoy Pump Service \$27,840 for the well pull plus televised documentation of the well equipment –"Phase One". This was seconded by Trustee Shelton. Ayes: Trustees Plock, Shelton, Goodrich and Taylor. Nays – 0; Absent (2)- Trustees Groen and Simms. Motion Carried

Trustee Shelton motioned to pay the renewal to *IML/RMA I the amount of \$16,850.31 this total includes a 1% discount if paid prior to November 15, 2024. This was seconded by Trustee Plock. Ayes: Trustees Shelton, Plock, Goodrich and Taylor. Nays – 0; Absent – (2) Trustees Groen and Simms. Motion Carried.
